



MAXI-CASH "PAWN & WIN CASH" LUCKY DRAW PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in Maxi-Cash "Pawn & Win Cash" Lucky Draw Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.

2. The promoter is Maxi Cash (Southern) Sdn. Bhd.

ELIGIBILITY

3. The Promotion is open to all customers of the promoter who:

- I. are residents or permanent residents of Malaysia;
- II. are aged 18 years and over;
- III. have a valid Malaysian identification card

4. Employees (and their immediate family and/or those living in the same household) of the Promoter, and its respective affiliates, subsidiaries, agencies and suppliers associated with this Promotion are not eligible to enter.

PROMOTION PERIOD

5. The Promotion Period is from Saturday, 1 August 2020 till Saturday, 31 October 2020 ("Promotion Period"). The Promotion Period may be changed by the promoter at its discretion.

6. Incomplete or indecipherable entries will be deemed invalid.

7. All entries received before or after the Promotion Period shall be automatically disqualified.

CONTEST MECHANICS

8. To enter, individuals must complete a 3-month loan tenure with at least 3 months of loan interests paid to qualify. An entry form will be provided to qualified individuals upon the completion of the 3rd month interest payment.

9. Winners shall be selected at random, either by hand or by other means and methods (which may be manual or computerized) as the Promoter determines at its discretion. The Promoter may select additional reserve entry, in case of an invalid entry or ineligible entrant.

The Promoter may select additional reserve entry, in case of an invalid entry or ineligible entrant.

12. The winners will be notified via e-mail or telephone call on

- Saturday 9th to Monday 11th January 2021 for September 2020 entries
- Tuesday 8th to Friday 11th February 2021 for October 2020 entries

13. The winner must acknowledge acceptance of and claim their Prize within fourteen (14) days from the date of notification from Promoter.

14. If for any reason a winner does not acknowledge acceptance of and claim their Prize by the stipulated deadlines, the Prize will be forfeited.

15. The Promoter will have no liability for a winner's failure to receive notices due to winner's spam, junk email, other e-mail security settings, inability to answer phone calls or for a winner's provision of incorrect or otherwise non-functioning contact information.

THE PRIZE

16. The thirty (30) winners of the Prize, will receive: cash amount equivalent to the 3 months' worth of interests paid by the winner during the promotion period with the cash prize capped at RM600 prize per winner.

GENERAL

The Promoter reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
